Aims and objectives

1. Provide treatment of disease, disorder or injury under the NHS to all patients registered with the practice from the Cartmel Peninsula area
2. Provide all suitable and appropriate diagnostic and screening procedures available under the NHS to all patients registered with the practice from the Cartmel Peninsula area
3. Provide maternity and midwifery services under the NHS to any patient from the Cartmel Peninsula area that wishes to receive care from the practice in association with other local NHS midwifery and maternity providers
4. To provide enhanced NHS care services to all patients registered with the practice from the Cartmel Peninsula area, including surgical procedures, enhanced access hours, and specialist clinic services
5. To provide family planning services (including the fitting of IUCD and hormonal implants) to any patient from the Cartmel Peninsula area that wishes to receive care from the practice. Patients do not need to be registered with the practice to receive such care under the NHS
6. To provide any other service to our patients, outside of the NHS, that require the care or support of their regular medical practitioner, such as medical reports or travel immunisations; however these service will incur a reasonable charge from the practice
